Now accepting applications for the dismantling/removal of damaged houses etc.

Based on the property owner's application, Kumamoto city will dismantle/remove those houses etc. determined to be *over half-destroyed* in the earthquake according to their disaster victim certificate.

Registration for dismantling/removal applications (distribution of <u>reservation ticket</u> and <u>application documents</u>) will commence **Monday, June 13th**. A citizen inquiries phone line, "*Hisai-Kaoku-Kaitai-Dial*" opened on **Wednesday, June 8th**.

- 1 Target applicants for dismantling/removal
- Applicants for dismantling/removal (according to this system) must meet all of the following requirements and conditions:
- ① <u>Must</u> be the owner of a house etc. determined to be *over half-destroyed* on the corresponding <u>disaster victims certificate</u>
- Must have been the owner of the said property on April 16th, 2016 (during the mainshock of the 2016 Kumamoto Earthquake)
 - *Exceptions may apply if the property owner perished after April 16th, 2016.
- 2 Application process for the dismantling/removal of damaged house etc.
 - (1) Distribution of reservation tickets

We will distribute <u>reservation tickets</u> stating the date and time applications for dismantling/removal will be accepted

(Reservations can be made starting from Wednesday, June 22nd, 2016)

* Reservation tickets are needed beforehand in order to register for a dismantling/removal application.

- (1) Those who have already had their houses dismantled/removed at their own expense are still applicable to this system.

Owners of a house etc. that has been determined as *over half-destroyed* according to their <u>disaster victim certificate</u> and who have a copy of the contract and/or invoice for the completed payment of the dismantling/removal of their property.

*Applicants must have had the contract for the dismantling/removal of their house completed by June 21st, 2016 (one day before the commencement of city dismantling/removal registration)

Contracts for an "own expense" dismantling/removal completed after June 22nd do not apply.

Contract completed by Tuesday June 21st, 2016 → Applicable with this system

Contracts completed after Wednesday June 22nd, 2016 → Not applicable with this system

(2) About dismantling/removal fees

- ① The dismantling/removal fees will be whichever of the two amounts—either the amount calculated by the city or the amount charged by the private contractor—is lower.

 *Costs accrued for the removal of "non-reimbursable items" do not apply.
- ② Applicant must pay the difference if the city's calculated amount is less than that which the private contractor charged.
